Membership Categories

The Association has nine categories of membership which are open to licensed asbestos removal companies, UKAS accredited laboratories, consultants and organisations providing goods or services to the industry, and companies with an interest in the asbestos abatement industry.

The stringent entrance requirements and conditions of membership apply in order to satisfy the Association's Governing Council that standards are meticulously maintained. Adherence to a set of Rules of Membership forms part of the membership criteria.

Full Contracting Member

Shall be a company engaged in the removal of asbestos materials and who complies with the conditions of membership.

Example Company Type:

HSE Licensed Asbestos Removal Contractor

Registration Fee: £1,100 +VAT

(Deducted from first Annual Subscription Invoice)
Annual Membership Fee: £3,800 +VAT

includes £1,300 of credits for ARCA training and fully

inclusive of four ARCA site audits.

Full Contracting Member Republic of Ireland & Northern Ireland

Shall be a company engaged in the removal of asbestos materials and who complies with the conditions of membership.

Example Company Type:

HSE Licensed Asbestos Removal Contractor based in Northern Ireland, or Republic of Ireland Asbestos

Full Member Non–Contracting (ATaC)

Shall be a person or company which fulfils the criteria of the Asbestos Testing & Consultancy Division (ATaC). Example Company Type:

UKAS accredited laboratory for asbestos services

Registration Fee: None

Annual Membership Fee: £1,100 +VAT

includes £400 of credits for RSPH qualifications

delivered by ATaC.

Full Member Non-Contracting (Associate)

Shall be a person company or organisation which fulfils Associate membership status, but who also requires voting rights and the opportunity to stand for election to the Governing Council.

Asbestos equipment/services manufacturer/distributor

Registration Fee: None

Annual Membership Fee: £1,100 +VAT

Annual Membership Fee (Associate Member - Licence

Holder): £1,375 +VAT

Labour Supply Member

Shall be a company supplying operative labour to the licensed asbestos removal industry.

Example Company Type:

Specialist asbestos recruitment agency

Registration Fee: £600 +VAT

(Deducted from first Annual Subscription Invoice)
Annual Membership Fee: £3,100 +VAT

includes £1,300 of credits for ARCA training and fully

inclusive of two ARCA office audits.

Associate Member

Shall be a person, company or organisation that provides an industry related service to Full Contracting Members, This category of membership is also available for overseas companies (outside of the UK and ROI) who are involved in asbestos removal.

Example Company Type:

Asbestos equipment/services manufacturer/distributor

Registration Fee: None

Annual Membership Fee: £600 +VAT

Associate Member - Licence Holder

Shall be a company or organisation which provides an industry related service to Full Contracting Members and holds a licence from the HSE to carry out this service.

Example Company Type:

Scaffolding and equipment maintenance

Registration Fee: None

Annual Membership Fee: £950 +VAT

Corporate Member

Shall be a company or organisation which operates in the following sectors: building, construction and property, Local Authorities, Housing Associations, and Trade Associations with members operating in these sectors. Corporate Membership entitles the company to five places per annum on ARCA's leading Asbestos Awareness training course.

Information Service Member

Shall be a company or organisation, such as a Local Authority, construction contractor, information service provider. Information Service Members are not entitled to use the ARCA logo.
